Exposure to Innovation: Aims for thematic exposure to "Space Exploration", including orbital and sub-orbital aerospace, enabling technologies, and beneficiaries of aerospace activities, such as agriculture, Internet access, global positioning system (GPS), construction, and imaging.1



Growth Potential: Aims to capture long-term growth with low correlation of relative returns to traditional growth strategies.



Tool for Diversification: Offers a tool for diversification due to little overlap with traditional indices. It can be a complement to traditional value/growth strategies.



Grounded in Research: Combines top-down and bottom-up research in its portfolio management to identify space innovation companies and convergence across markets.



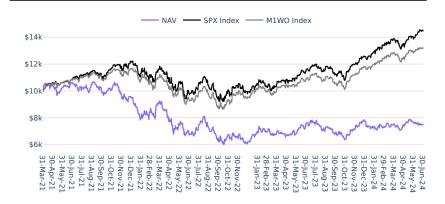
Cost Effective: Provides a lower cost alternative to mutual funds with true active management in an Exchange Traded Fund (ETF) that invests in a rapidly moving theme.

[1] Advisor Definitions: Orbital Aerospace Companies are companies that launch, make, service, or operate platforms in the orbital space, including satellites and launch vehicles. Suborbital Aerospace Companies are companies that launch, make, service, or operate platforms in the suborbital space, but do not reach a velocity needed to remain in orbit around a planet. Enabling Technologies Companies are companies that develop technologies used by Space Exploration related companies for successful value-add aerospace operations.
